

Dear Valued Provider Partner,

Effective May 6th, 2025, Providence Health Plan will require prior authorization for cardiovascular services through Carelon Medical Benefits Management. This change does not apply to Medicaid or self-funded employer groups.

Carelon collaborates with top health insurers to improve healthcare quality and manage costs for complex and advanced tests and treatments, ensuring that care is appropriate, safe, and affordable.

Starting **May 6th**, **2025**, providers of these services are required to participate in the Outpatient Cardiovascular program and contact Carelon for authorization of elective cardiovascular services.

Requirements

Beginning **April 21**, **2025**, providers are required to submit authorization requests to Carelon for cardiovascular services scheduled on or after **May 6th**, **2025**. Typically, these reviews are conducted prior to the delivery of services, and providers are strongly encouraged to secure authorization before performing any outpatient cardiovascular services.

Outpatient Cardiovascular Services Requiring Carelon Prior Authorization:

Cardiovascular Ultrasound

- Arterial Duplex
- Arterial Physiologic Study

Coronary Angiography and Interventions

- Diagnostic Coronary Angiography
- Percutaneous Coronary Intervention
- Cardiac Ablation
- Electrophysiology Study
- Septal Defect Closure (PFO)

Cardiac Devices

- Cardioverter Defibrillators
 - o Implantable
 - Wearable (Commercial only)
 - Cardiac Resynchronization Therapy
- Pacemakers
- Cardiac Rhythm Monitors

Vascular Interventions

- Dialysis Circuit Access Intervention
- Peripheral Arterial Revascularization
- Vascular Embolization or Occlusion

Procedures performed in an inpatient setting or on an emergent basis, such as those performed during an ER evaluation prior to patient discharge, are exempt from the program.

Note: As of 4/1/2025, the <u>Providence Health Plan Prior Authorization List will</u> include all applicable CPT/HCPCS codes for cardiac services requiring PA through Carelon.



How to Submit a Request for Review

Starting **April 21**, **2025**, providers can submit prior authorization review requests or verify order numbers through the following methods:

 - Access the <u>Carelon Provider Portal</u>, available 24/7, for real-time processing with clinical criteria.
